## EDUCATION, HEALTH AND WELL-BEING Information Sheet

---

### Overview:

After a lengthy consultation period between Genesis Energy and Ngati Tuwharetoa, in 2000 the Tuwharetoa Maori Trust Board (on behalf of nga hapu o Ngati Tuwharetoa) and Genesis Energy signed an agreement to mitigate the on going impacts of the Tongariro Power Scheme on Ngati Tuwharetoa.

An outcome of this agreement is the establishment of Ngati Tuwharetoa – Genesis Energy Committee. The primary purpose of the Committee is to distribute the mitigation funds on behalf of Ngati Tuwharetoa as per the objectives set out below.

This information sheet details the objectives as well as the funding criteria for those wishing to apply for funding assistance for an **EDUCATION, HEALTH OR WELL-BEING** activity.

The Committee meets at least every two months, to consider applications.

### Key Objective:

The key objective of the Group that relates specifically to EDUCATION, HEALTH OR WELL-BEING is:

**1. To promote projects to facilitate the education, health and well-being of Tuwharetoa youth.**

*Explanation: facilitate educational development of Ngati Tuwharetoa (especially Tuwharetoa youth) and promote their health and well-being, including educational, sports and recreational activities. The outcomes of these initiatives shall be communicated to wider Ngati Tuwharetoa where applicable.*

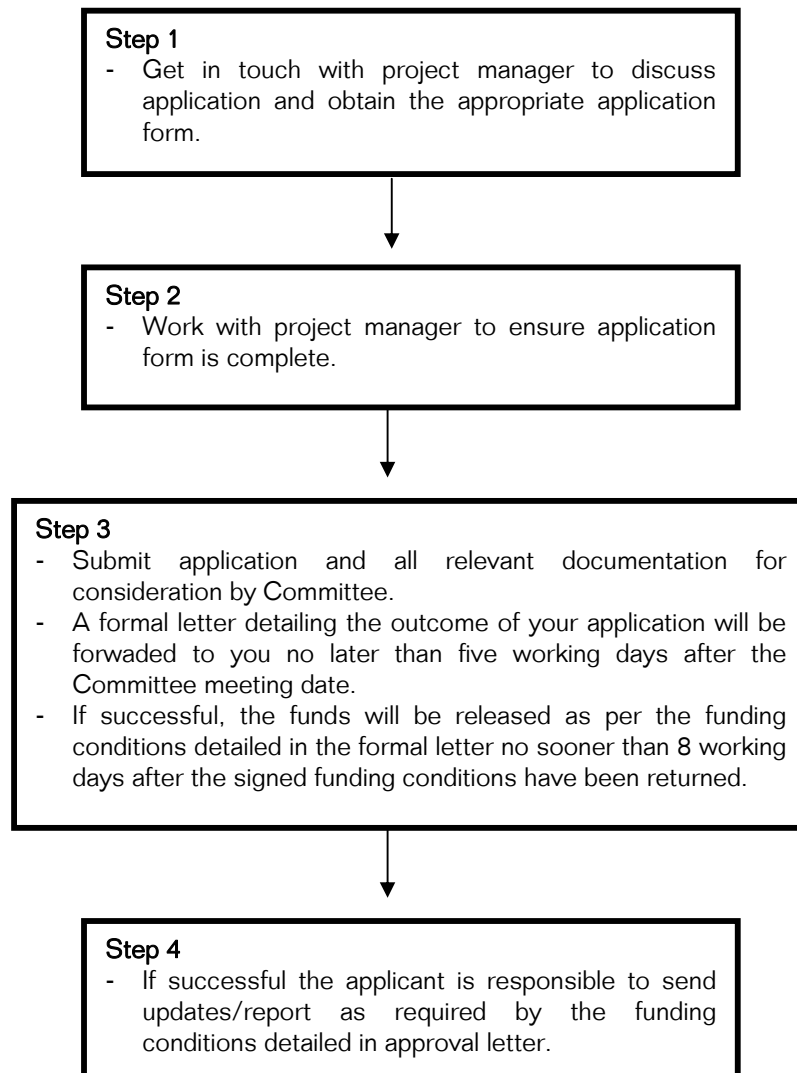
### Funding Criteria:

1. Applicant must be of Ngati Tuwharetoa descent.
2. The applicant must clearly demonstrate how the proposal will contribute to achieving the key objective shown above.
3. Applicants for '**education assistance**' must demonstrate that their proposal will lead to a tertiary qualification in areas related to natural resource management, planning and/or environmental sciences.
4. Preference will be given to those applications that have wide benefit (and clearly show how the outcomes will be communicated) to Ngati Tuwharetoa at the hapu and/or iwi level.
5. Preference will be given to those proposals that have the support of other parties/organisations.
6. The criteria for those applying for sporting funds is as follows;
  - Only those representing NZ at an international competition will be considered (confirmation will be required).
  - Teams seeking support must clearly demonstrate how they are utilising Tuwharetoatanga.
7. If successful, the applicant will be required to provide written feedback to the Committee on the outcome of their proposal and may be asked to report back to the Committee at a suitable time.
8. The Committee retain the right to withdraw any funding if agreed project time frames have not been met and/or there has been no communication between the parties.

**Projects that will not be considered by the Committee:**

1. Applications that are incomplete or require further information.
2. Applications for 'education assistance' for items such as computers, text books or other course related costs (however, the Committee may consider granting assistance for course fees that will be paid directly to the provider).
3. Projects that may be more appropriately funded from other sources.
4. Projects that have been completed prior to applying for funding.
